

INFORMATION FOR STUDENTS WHO ARE NOT TRAVELING HOME WITH THE BAND: Florida Trip 2012.

We have put together this form to answer questions people may have about continuing their vacation in Florida. Our number one concern is that the student is released to a proper parent, guardian, or authorized person. Furthermore, we must also make sure that the student's departure, or problems with the departure don't effect the other students. Once a student is signed out, they are legally out of our care and may not rejoin the trip. With these situations in mind, we have come up with the following policy:

LEAVING PRIOR TO MARCH 19th:

Students may leave the trip at any time until March 19th. All times must be prearranged with the directors. Parents need to complete the "Student Leaving Early" form. (FORM #3)

LEAVING ON MARCH 17th:

We will be checking out of the hotel (Rosen Center) at 7:00AM for our last day activities. Any luggage placed on the bus at this time, will be returning to Stow.

- * ALL STUDENTS NOT RETURNING HOME WITH THE BAND must have luggage picked up at the Hotel by 7:00AM as we will not have access to our busses or the ability to store any luggage during the day.
- * Parents may opt to withdraw students from the trip at this time, (7:00AM) or
- * The student may attend the day's activities and be picked up at Disney Hollywood Studios (formally MGM)

at 1:45 PM. The meeting location will be the main gate. or
at 6:00 PM. The meeting location will be the main gate.

Again, there will not be a way to get luggage off the bus at this time as the drives will be on their required 8 1/2 hours off before driving home.

FINAL ITEMS:

- * Any Food (Money) disbursements during the trip home will be kept and given to the student when we return to school after break.
- * Parents need to complete the "Student Leaving Early" sheet in both situations.

The meeting location will be just outside the main gate. This form should be returned on Packing Night (Wednesday, March 14th)
